## Your donations are having an impact!

It has been less than 3 months since we learned about the White Township Supervisors' 3rd attempt in 25 years to log White's Woods. This time, they plan to remove 50-60% of the tree canopy and use destructive methods to deal with invasive plants that are destined to backfire. It's far from over, but with your help, we have been able to halt this work in several ways:

**Legal action.** We hired a legal team from Fair Shake Environmental Legal Service, a nonprofit lawfirm that specializes in environmental justice. They helped us file a lawsuit against the Supervisors for keeping the public out of the loop on decisions about White's Woods.

**Forestry consultation.** We hired a forester from Appalachian Forest Consultants to make independent assessments of the health of White's Woods and Mike Lawer of Millstone's plan. He contacted the PA Bureau of Forestry to express his strong objection to Lawer's rationale and methods.

**Raising awareness.** We made yard signs, posters, face masks, and stickers to get the word out that White's Woods is at risk of being destroyed. Want one? Email us! [info@friendsofwhiteswoods.org](mailto:info@friendsofwhiteswoods.org)

### Did you know?

White's Woods Nature Center is of important historical value. Part of the land once the province of Iroquois and Monongahela people, White's Woods was named for Thomas White, legal agent for George Clymer, who signed both the Declaration of Independence and the United States Constitution.

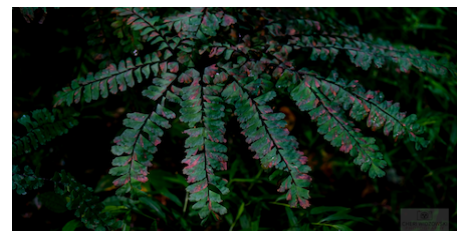

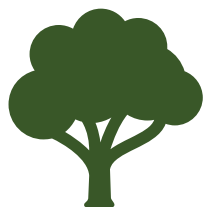
