Dear White Township Voter,

The White Township Board of Supervisors is asking for your assistance by completing the attached survey and returning it to the Township Office in the enclosed self-addressed, stamped envelope. This survey is being sent to all registered voters in White Township. The results will be used to assist the Board of Supervisors in preparing a Comprehensive Recreation Master Plan for White's Woods and in determining the level of any future development that could occur in that area.

A key question involves the cutting of timber in the park area. Please keep in mind that any timbering done would be on a selective cutting basis, and would not involve clear cutting the White's Woods area. Funds received from any timbering of White's Woods would be set aside for improving or developing additional recreation facilities in the Township.

As a brief history, the White's Wood property, consisting of 250 acres located adjacent to the northwest corner of Indiana Borough, was purchased in 1968 using funds from a State Grant (50%) and funds borrowed by the Township (50%). Since its purchase, the land has remained relatively undeveloped except for a hiking trail system, and gas well and utility line construction. The area is maintained by the Indiana Area
